An ordinance amending County Ordinance No. 62 SUMMARY: to provide for amendments to Master Plan of Streets and Highways approved January 25, 1966.

BILL NO. 143

ORDINANCE NO. 62

AN ORDINANCE TO AMEND SECTION 2 OF COUNTY ORDINANCE 62 ENTITLED: "AN ORDINANCE ADOPTING A MASTER PLAN OF STREETS AND HIGHWAYS FOR THE COUNTY OF WASHOE."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 2 of County Ordinance No. 62 is hereby amended to read as follows:

## Section 2. Maps

The Master Plan of Streets and Highways for Washoe County shall be indicated on that map entitled "Regional Master Plan Study #1, as amended, Streets & Highways, a part of the Master Plan for Washoe County, Nevada". The aforesaid map was approved by the Board of County Commissioners of Washoe County at a public hearing on said Master Plan on July 9. 1965. Amendments to said map and Master Plan were approved by the Board of County Commissioners at a public hearing held on January 25, 1966. Said map, together with all amendments thereto, shall be on file in the office of the County Clerk of Washoe County, Nevada. Said map together with all notations, information and data contained thereon is hereby adopted as the Master Plan of Streets and Highways for Washoe County and by reference incorporated herein and made a part of this Ordinance.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
