ORDINANCE NO. 67

AN ORDINANCE RATIFYING, APPROVING AND CONFIRMING THE ORGANIZATION OF THE WASHOE COUNTY FAIR AND RECREATION BOARD; AND DECLARING AN LMERGENCY.

WHEREAS, all action preliminary to and in the organization of the Washoe County Fair and Recreation Board has been duly taken; and

meet in regular session on wery Wednesday morning of each month, at 8:00 o'clock A.m., at Commissioner Normal House, Rono, in Washoe County, Nevada; and

whereas, due to the necessity of immediately creating a county fair and recreation board so that it can exercise the powers granted by MRS 244.040 to 244.700, inclusive, and can promptly acquire the facilities therein authorized, the board of County Commissioners has determined, and does hereby declare, that an emergency exists requiring this ordinance to take effect from and after its passage and publication by title in accordance with law.

NOW, THEREFORE, THE EOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF MASHOE, IN THE STATE OF NEVADA, DOLS ORDAIN:

Section 1. That all action taken preliminary to and in the organization of the Washoe County Fair and Recreation Board be, and the same hereby is, ratified, approved and confirmed.

Section 2. That all by-laws, orders, resolutions, and ordinances, or parts of by-laws, orders, resolutions, and ordinances, in conflict with this ordinance, are hereby repealed. This repealer shall not be construed to revive any by-law, order, resolution or ordinance, or part thereof, heretofore repealed.

Section 3. That if any one or more sections, sentences, clauses, or parts of this ordinance shall, for any reason, be questioned or be held invalid, such judgment shall not affect,

impair, or invalidate the remaining provisions of this ordinance, but shall be confined in its operation to the specific sections, sentences, clauses, or parts of this ordinance so held unconstitutional and invalid, and the inapplicability and invalidity of any section, sentence, clause or part of this ordinance, in any one or more instances shall not affect or prejudice in any way the applicability and validity of this ordinance in any other instances.

Section 4.
