AN ORDINANCE TO AMEND COUNTY ORDINANCE 68 ENTITLED:
"AN ORDINANCE CREATING A COUNTY DEPARTMENT OF WELFARE:

"Section 2. The Welfare Director is expressly authorized to exercise those powers and perform those duties granted to the Board of County Commissioners under N.R.S. §428.070 in the performance of his duties delegated by Section 1 of this Article."

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
