ORDINANCE NO. 86

AN ORDINANCE TO AMEND BY ADOPTING THE UNIFORM HEATING AND COMFORT COOLING CODE, 1964 EDITION, COUNTY ORDINANCE 86 ENTITLED: "AN ORDINANCE OF THE COUNTY OF WASHOE REGULATING THE INSTALLATION, ALTERATION AND MAINTENANCE OF WARM AIR HEATING SYSTEMS, PROVIDING FOR THE ISSUANCE OF PERMITS FOR WARM AIR HEATING INSTALLATION AND THE INSPECTION THEREOF, PROVIDING PENALTIES FOR THE VIOLATION THEREOF, REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. County Ordinance 86 is hereby amended by changing the Summary and Title of said Ordinance to read as follows:

SUMMARY: An ordinance adopting a code prescribing minimum standards for the use, design and installation of Heating and Comfort Cooling Equipment for Washoe County.

AN ORDINANCE OF THE COUNTY OF WASHOE PROVIDING FOR THE PROTECTION OF THE PUBLIC HEALTH AND SAFETY BY PRESCRIBING MINIMUM STANDARDS FOR THE USE, DESIGN AND INSTALLATION OF HEATING AND COMFORT COOLING EQUIPMENT; REQUIRING A PERMIT AND INSPECTION FOR THE INSTALLATION, ALTERATION AND REPLACEMENT OF SAID EQUIPMENT; PROVIDING FOR THE ADMINISTRATION AND ENFORCEMENT OF SUCH REQUIREMENTS; PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO.

Section 2. County Ordinance 86, Section 1 is hereby amended to read as follows:

"Section 1. The Uniform Heating and Comfort Cooling Code, 1964 Edition, adopted at the Thirty-Fourth Annual Conference of the Western Plumbing Officials Association, October 1963, together with such changes as are necessary to make the same applicable to conditions in the County of Washoe and with such other changes as are desirable, all of which changes are marked "Exhibit A" and placed on file in the office of the County Clerk of Washoe County, Nevada, shall be and hereby is adopted by reference, incorporated herein and made a part hereof as if set forth in full."

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval as prescribed by NRS §244.105.

- 5.00 for each circulating type heater.
