ORDINANCE NO. 88

AN ORDINANCE CREATING A COUNTY PARK COMMISSION FOR WASHOE COUNTY, NEVADA, PROVIDING FOR THE APPOINTMENT OF MEMBERS THEREOF AND DEFINING THE DUTIES OF THE COMMISSION.

The Board of County Commissioners of the County of Washoe, State of Nevada, do ordain:

ARTICLE 1. Establishment thereof.

SECTION 1. There is hereby created a commission to be known as the Washoe County Park Commission, referred to hereinafter in these articles as the Commission.

ARTICLE 2. Commission.

SECTION 1. The Commission shall consist of seven (7) members, appointed by the Washoe County Board of County Commissioners. Members shall be chosen on the basis of their experience, interest in civic and public affairs and particularly their interest in the development and improvement of the park and recreational facilities in Washoe County. Their terms of office shall be for a period of four (4) years, provided that the respective terms of office of those first appointed shall be as follows: Two for two years, two for three years, and three for four years from the effective date of this article. Vacancies occurring in the offices during or at the expiration of terms shall be filled by the Washoe County Board of County Commissioners. Not less than two members of said Commission shall be women.

SECTION 2. The members of the Commission shall contribute their services on a voluntarily basis, without any compensation, but reasonable and necessary expenses of the Commission, if first approved by the Board of County Commissioners of Washoe County, shall be paid. The Commission at its first meeting shall elect a chairman from the Commission's membership; thereafter, the Commission shall elect such other officers thereof as it may from time to time deem necessary.

ARTICLE 3. Duties of the Commission.

SECTION 1. The Commission shall:

- a. Prepare a long-range program of park development for Washoe County, and in this connection shall work with the Regional Planning Commission of Reno, Sparks, and Washoe County.
- b. Submit the proposed program of long-range park development within one year from the effective date of this article.
- c. Make recommendations to be submitted in writing to the Board of County Commissioners of Washoe County each year thereafter, said recommendations to be filed prior to July of each year relative to the establishment, operation and development of parks in Washoe County.
- d. Supervise the implementation of the program and recommendations as approved by the Board of County Commissioners of Washoe County.
- e. Meet at least four (4) times in each calendar year.
