THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Section 2(b) of County Ordinance No. 93 is hereby amended to read as follows:

A person under the age of twenty-one (21) years except those between the ages of 18 and 21 whose duties do not require them to be in any area on the premises where alcoholic beverages are dispensed or where gambling or banking games of any kind or nature are operated, installed, or set up for the use of the general public.

- Section 2. Section 5 of County Ordinance No. 93 is hereby amended by adding a subsection to read as follows:
 - (d) Allowing minors in any area on the premises where alcoholic beverages are dispensed or where gambling or banking games of any kind or nature are operated, installed, or set up for the use of the general public.
- Section 3. Section 5 of County Ordinance No. 93 is hereby amended by adding a subsection to read as follows:
 - (e) The licensee is no longer a suitable person to hold a license, after due consideration by the Board of the proper protection of the public health, safety, morals, and good order and the general welfare of the inhabitants of the County.
- Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS §244.100.
