AN ONDINANCE DEFINING A REGIONAL PLANNING DISTRICT; EMPOWERING A REGIONAL PLANNING COMMISSION TO ACT FOR AND ON BEHALF OF THE COUNTY OF WASHOE IN ALL PLANNING DUTTES AND PLANNING FUNCTIONS: PROVIDING FOR THE APPOINTMENT AND COMPLISATION OF CERTAIN OF THE MEMBERS OF THE PLANNING COMMISSION, THE APPROPRIATION OF FUNDS FOR EXPENSES OF THE PLANNING COMMISSION, AND OTHER MATTERS PROPERLY RELATED THERETO, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Washoe County part of regional planning district. The County of Washoe is hereby declared to be part of a regional planning district, the boundaries of which district shall be the boundaries of Washoe County, Nevada.

Section 2. Representation of county on planning commission. The County of Washoe shall be represented in a regional planning commission, which commission is hereby authorized to act for and on behalf of the County of Washoe as a planning commission which shall fulfill all of the auties and functions of a planning commission as set forth in the enabling act, NRS 278.090 - 278.260

Section 3. County participation conditioned upon membership. The participation of the County of Washoe in the regional planning commission as set forth in this ordinance is authorized only under the condition that the total membership of the regional planning commission shall consist of 12 members, each of whom shall be appointed for a term of 4 years or until his successor takes office.

Section 4. Appointments, terms of county members.
The board of county commissioners shall appoint 4 members of the regional planning commission. The 4 members to be appointed on or after July 1, 1961, shall be appointed to fill the vacancies on the commission, as the respective terms expire, for a period of 4 years, expiring on June 30th., or until his successor takes office, except that the terms of 2 of the members first appointed shall be 3 years, and the respective terms of 2 of the members first appointed shall be 1 and 2 years and providing further that members appointed prior to Feb. 15, 1959, under the previous ordinance may serve out the balance of the term for which they were appointed. No more than one-third of the members shall hold any other public office.

Section 5. Members: Service without compensation: removal; vacancies.

1 2 3	All members of the regional planning commission shall serve with- out compensation. They may be removed, after public hearing, by a majority vote of the board of county commissioners for ineffi- ciency, neglect of duty, or malfeasance of office. Vacancies occurring otherwise than through the expiration of term shall be filled for the unexpired term.
4 5 6 7 8	Section 6. Appropriation of funds for commission use. The Board of County Commissioners shall appropriate funds annually for the use of the regional planning commission, such funds to be made a part of the budget of Washoe County. The regional planning commission shall have no authority to expend any funds of Washoe County in excess of those as appropriated, but may negotiate for gifts, Federal or State grants, or other funds, and may expend same only within the total amounts as acquired.
9	Section 7. Repeal. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
