SUMMARY: Amends provisions of Ordinance No. 105 relating to job-connected injuries.

BILL NO. 323

ORDINANCE NO. 105

AN ORDINANCE AMENDING WASHOE COUNTY ORDINANCE NO. 105 BY AUTHORIZING EMPLOYEES SUFFERING JOB-CONNECTED INJURIES OR ILLNESSES TO ELECT TO RECEIVE ACCRUED SICK LEAVE AS A SUPPLEMENT TO NEVADA INDUSTRIAL COMMISSION DISABILITY BENEFITS; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Section 5B of Ordinance No. 105 is hereby amended to read as follows:

SECTION 5. Sick Leave.

- B. (1) Any employee who suffers a job-connected injury or illness in the course and scope of his employment with the County of Washoe, for which the Nevada Industrial Commission pays benefits, shall not be required to use accrued sick leave for the period during which Nevada Industrial Commission benefits are being received.
- (2) Any employee who suffers a job-connected injury or illness in the course and scope of his employment with the County of Washoe for which the Nevada Industrial Commission pays benefits under Chapter 616 or 617 of the Nevada Revised Statutes may, at the option of said employee, apply for and receive accrued sick leave during the course of such disability. The amount of sick leave benefit paid to such employee for any pay period shall not exceed the difference between his normal salary and the amount of any benefit received, exclusive of reimbursement or payment of hospital or medical expenses.
- (3) An employee shall be entitled to receive all unused accrued sick leave and accrued annual leave upon termination from employment with the County of Washoe as a result of a permanent disability, whether or not such disability is a result of an injury or illness for which the Nevada Industrial Commission pays benefits.

SECTION 2.

This Ordinance shall be in full force and effect from and after its approval, passage and publication as prescribed by NRS 244.100.


