ORDINANCE NO. 106

AN ORDINANCE DEFINING A REGIONAL PLANNING DISTRICT: EMPOWERING A REGIONAL PLANNING COMMISSION TO ACT FOR AN ON BEHALF OF THE COUNTY OF WASHOE IN ALL PLANNING DUTIES AND PLANNING FUNCTIONS: PROVIDING FOR THE APPOINTMENT AND COMPENSATION OF MEMBERS: THE APPROPRIATION OF FUNDS FOR EXPENSES THEREOF: AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

SECTION 1: Washoe County a part of Regional Planning District. That portion of Washoe County lying westerly of dividing crest of the Sierra Nevada Mountains and comprising the watershed area of the Lake Tahoe basin is hereby declared to be part of a regional planning district.

SECTION 2: Representation of County on Planning Commission. This Commission shall be known as The Lake Tahoe Planning Commission and the County of Washoe shall be represented therein, which commission is hereby authorized to act for an on behalf of the County of Washoe as a Planning Commission which shall fulfill all of the duties and functions of a Planning Commission as set forth in the enabling Act, Chapter 278, NRS., and all acts amendatory thereto.

SECTION 3: County participation conditioned upon membership.
Participation of the County of Washoe in the Lake Tahoe Regional Planning Commission, as set forth herein, is authorized under the condition that the total membership of said commission shall consist of six (6) members, each of whom shall be appointed to a term of four (4) years, or until his successor takes office; except that the terms of two (2) of the members first appointed shall be three (3) years; and the respective terms of two (2) of the members first appointed shall be one (1) and two (2) years; and provided further that the Counties of Ormsby and Douglas participate with Washoe County in said commission

The Board of Washoe County Commissioners shall appoint two (2) members of the Lake Tahoe Regional Planning Commission. One such member shall be appointed for a term of Three (3) years, the other shall be appointed for a term of Two (2) years, with all subsequent appointments for a full term of four (4) years. Provided

1	no more than one-third (1/3) of the members of the Lake Tahoe Regional Planning Commission shall hold any other public office.
3	SECTION 5: Expiration of Terms. All terms of present members of the Lake Tahoe Regional Planning Commission shall expire upon the effective date of this Ordinance.
4	Terms of office of each member appointed hereto shall expire on the 30th day of June of the respective year of expiration of the
