7 ADOPTED A FIRE PREVENTION CODE PRESCRIBING REGULATIONS GOVERN-

13 SECTION 1. Repeal thereof.

14 Bill No. 60, Ordinance No. 100 is hereby repealed, said ordi-
15 nance having adopted a fire prevention code prescribing regu-
16 lations governing conditions hazardous to life and property
17 from fire or explosion, and establishing a Bureau of Fire Pre-
18 vention and providing officers therefor and defining their
19 powers and other duties, said ordinance having been passed on
20 the 5th day of July, 1961, and having been in force and effect
21 since the 14th day of July, 1961.

22 SECTION 2. This ordinance shall be in effect from and after its
23 passage and approval and publication in accordance with NRS
24 244.100.
