ORDINANCE NO. 136

AN ORDINANCE AMENDING THE TITLE OF WASHOE COUNTY ORDINANCE NO. 136.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. The title of Washoe County Ordinance No. 136 is hereby amended to read as follows:

"An Ordinance prohibiting the discharge of firearms on or across County roads; prohibiting the discharge of certain described firearms within 5,000 feet of a dwelling in the unincorporated area of the County; prohibiting the discharge of certain described firearms within 1,000 feet of a dwelling in the unincorporated area of the County; prohibiting the discharge of firearms within a defined congested area in the unincorporated area of the County; requiring reasonable posting by the County of congested areas in which the discharge of firearms is prohibited; prescribing penalties for the violation thereof; and other matters properly relating thereto."

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
