BILL NO. 217  
ORDINANCE NO. 162

AN ORDINANCE RESTRICTING PARKING ON THE WEST SIDE OF U.S. HIGHWAY 395 SOUTH FROM 150 FEET SOUTH OF DEL MONTE LANE TO 300 FEET SOUTH OF PREMISES COMMONLY DESCRIBED AS 6335 SOUTH VIRGINIA STREET

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. Fact Finding

A sight distance problem is created by parked cars from 150 feet south of Del Monte Lane to 300 feet north of the premises commonly described as 6335 South Virginia Street.

Section 2. Corrective Action

Pursuant to N.R.S. §484.234 the State of Nevada, Department of Highways is hereby directed to install the necessary signs and paint the curbing red on the west side of Highway 395 South commencing about 150 feet south of Del Monte Lane to 300 feet north of the premises commonly described as 6335 South Virginia Street.

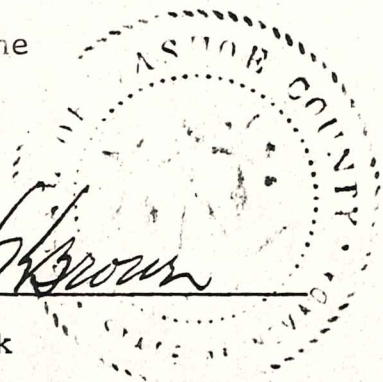
