SUMMARY: An Ordinance Revising Ordinance No. 175 by adopting the Air Pollution Control Regulations of the District Board of Health of the Washoe County Health District, effective February 1, 1973

ORDINANCE NO. 175

AN ORDINANCE ADOPTING THE AIR POLLUTION CONTROL REGULATIONS PROMULGATED BY THE DISTRICT BOARD OF HEALTH OF WASHOE COUNTY HEALTH DISTRICT, EFFECTIVE FEBRUARY 1, 1973; AUTHORIZING THE CONTROL OFFICER AS DEFINED IN SAID REGULATIONS TO ENFORCE SAME ON BEHALF OF THE COUNTY OF WASHOE; PROVIDING FOR PERMITS AND FEES AND DEFINING EXCEPTIONS THERETO AS SET FORTH IN SAID REGULATIONS; PRESCRIBING PENALTIES FOR VIOLATION OF ANY OF THE AFORESAID REGULATIONS; AND AMENDING ORDINANCE NO. 175 AND REPEALING ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

The Air Pollution Control Regulations, effective February 1, 1973, adopted by the District Board of Health of the Washoe County Health District, copies of which are placed on file in the Office of the County Clerk of Washoe County, Nevada, shall be and hereby are adopted by reference, incorporated herein, and made a part hereof as if set forth in full.

- A. Bill No. 105, Ordinance No. 129 of Washoe County entitled:

 "AN ORDINANCE CONCERNING AIR POLLUTION, ITS REGULATION,
 CONTROL AND PROHIBITION; PROVIDING FOR THE ISSUANCE OF
 A PERMIT FOR THE INSTALLATION OF FUEL BURNING EQUIPMENT
 AND DEFINING EXCLUSIONS THEREFROM; CREATING AN AIR
 POLLUTION CONTROL OFFICER AND DEPUTIES AND DEFINING
 THEIR DUTIES; PRESCRIBING PENALTIES FOR VIOLATION
 THEREOF AND PROVIDING OTHER MATTERS PROPERLY RELATING
 THERETO; AND REPEALING ORDINANCE NO. 79 AND ALL OTHER
 ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH."
 is hereby repealed and shall be of no force and effect
 from and after the effective date of this Ordinance.
 - B. Those provisions of any other ordinance of Washoe County or parts of ordinances in conflict or inconsistent herewith are hereby repealed but only to the extent of such conflict or inconsistence.

SECTION 3. Amending.

Section 1 of Washoe County Ordinance No. 175, Bill No. 251,
"AN ORDINANCE ADOPTING DISTRICT BOARD OF HEALTH'S AIR POLLUTION
CONTROL REGULATIONS OF SEPTEMBER 18, 1969; CREATING AIR POLLUTION
CONTROL OFFICERS AND DEPUTIES AND DEFINING THEIR DUTIES; PROVIDING FOR OPEN FIRE PERMITS AND DEFINING EXCLUSIONS THEREFROM;
PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF AND PROVIDING OTHER
MATTERS PROPERLY RELATING THERETO; AND REPEALING ORDINANCE NO.
129 AND ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT
THEREWITH." is hereby repealed.

The Control Officer defined in the Air Pollution Control Regulations incorporated in Section 1. above shall exercise such functions and carry out such duties as described in said Regulations on behalf of the County of Washoe.

SECTION 5. Penalties.

Any person who violates any of the provisions of the Air Pollution Control Regulations incorporated in Section 1. above shall be deemed guilty of having created a public nuisance, within the meaning of NRS 244.361, and shall be subject to the usual penalties for such crime as provided in the Nevada Revised Statutes. Nothing contained herein shall prohibit the enforcement of any other penalties for any other violations provided for in said Regulations.

SECTION 6. Effective date.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
