Notice is hereby given that Bill No. 292, amending Ordinance No. 177, entitled "An ordinance of Washoe County, State of Nevada, regulating the construction of mobile home subdivisions, the construction, use and operation of mobile home and recreational vehicle parks; providing penalties for violations thereof and other matters properly relating thereto," was adopted on June 5, 1972 by Commissioners Pagni, Coppa, Nelson, Rusk and McKissick all voting aye.

SUMMARY: Amends Ordinance No. 177 by authorizing parking of recreational vehicles outside recreational vehicle parks, and other matters properly related thereto.

BILL NO. 292

ORDINANCE NO. 177

AN ORDINANCE OF WASHOE COUNTY, STATE OF NEVADA, REGULATING THE CONSTRUCTION OF MOBILE HOME SUBDIVISIONS, THE CONSTRUCTION, USE AND OPERATION OF MOBILE HOME AND RECREATIONAL VEHICLE PARKS; PROVIDING PENALTIES FOR VIOLATIONS THEREOF AND OTHERS MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Article 7B 1 of Ordinance No. 177 is hereby amended to read as follows:

B. Location Outside Parks:

1. Nothing herein shall preclude parking of a recreational vehicle outside a recreational vehicle park provided all liquid and solid wastes from said vehicle shall be disposed in accordance with laws and regulations of the Nevada State and Washoe County Health Departments. Parking of any mobile home outside a mobile home park or mobile home subdivision when such mobile home is used for dwelling or sleeping purposes shall be unlawful.

SECTION 2.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
