ORDINANCE NO. 179

AN ORDINANCE ESTABLISHING THE 5TH, 15TH AND 25TH DAY OF EACH AND EVERY MONTH AS THE REGULAR MEETING DATES OF THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY, AND OTHER MATTERS PROPERLY RELATED THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

Section 1. Regular Meetings. The regular meetings of the Board of County Commissioners of Washoe County shall be held at Reno, Washoe County, Nevada, on the 5th, 15th and 25th day of each calendar month; provided:

- A. When such date falls on a Saturday or on any non-judicial day, such regular meeting shall be held on the next following judicial day.
- B. The first meeting of the Board in odd-numbered years shall be held on the first Monday in January.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.


