ORDINANCE

On motion duly seconded and carried by the unanimous vote of the Board, it was ordered that the following ordinance be adopted to-wit:

## ORDINANCE NO. 203.

AN ORDINANCE TO FIX, IMPOSE AND COLLECT A LICENSE TAX ON THE SALE OF INTOXICATING, SPIRITUUOUS, MALT, FERMENTED, OR OTHER LIQUORS OR WINES, AT ALL PLACES OUTSIDE OF THE LIMITS OF INCORPORATED CITIES AND TOWNS WITHIN THE COUNTY OF WASHOE, STATE OF NEVADA.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE, STATE OF NEVADA DOES ORDAIN:

SECTION 1. Every person, firm, association or corporation engaged in the business of dispensing intoxicating, spirituous, malt, fermented, or other liquors, or wines, or conducting a place of business or establishment for the dispensing of intoxicating, spirituous, malt, fermented, or other liquors, or wines, in the County of Washoe outside of any incorporated city of town therein shall secure a license therefor to be paid for and issued as provided for the payment and issuance of other county licenses, as follows:

- a. Retail establishment for the sale of intoxicating, spirituous, malt, fermented, or cother liquors, or wines, \$30.00 per quarter;
- b. Wholesale establishment for the sale of intoxicating, spiritmous, malt, fermented, or other liquors, or wines,\$45.00 per quarter;
- c. Merchandise or grocery store where intoxicating, spirituous, malt, fermented, or other liquors, or wines are sold \$45.00 per quarter;
  - d. Night or social club, \$60.00 per quarter;
  - e. Dance hall, with sleeping rooms or bedrooms in connection, \$300.00 per quarter.

where intoxicating, spirituous, malt, fermented, or other liquors, or wines, are sold to be drunk or consumed on the premises; a wholesale establishment is hereby defined as a place where intoxicating, spirituous, malt, fermented, or other liquors, or wines, are sold in wholesale quantities and unbroken packages or containers not to be consumed on the premises; a merchandise or grocery store is hereby defined as a place where the principal business carried on is the sale of groceries or other merchandise or household commodities, and intoxicating, spirituous, malt, fermented, or other liquors, or wines, are sold by the case, bottle, or in unbroken packages not to be consumed on the premises; a night or social club is hereby defined as a place where meals may or may not be served and music and entertainment provided, but having no sleeping rooms or bedrooms in connection therewith, and where no solicitation on the part of women is permitted for drinks or any other kind of business; a dance hall is hereby defined as a place where women are engaged or permitted to solicit drinks or trade of any kind, or a place with sleeping rooms or bedrooms in connection therewith.

SECTION II. Any person, firm association or corporation that sells or dispenses cof any intoxicating, spirituous, malt, fermented, or other liquors, or wines, without having first procured the necessary license as hereinbefore set forth, or otherwise violates, disobeys or refuses to comply with any of the provisions of this ordinance, shall be deemed guilty of a mis-demeanor, and upon conviction thereof shall be punished by a fine of not more than \$500.00, or imprisonment in the County Jail of Washoe County not to exceed six months.

SECTION III. This ordinance shall be in effect on and after the 5th day of December, 1933, and the County Clerk of Washoe County, as ex-officio Clerk of the Board of County Commissioners, is hereby authorized and ordered forthwith to cause this ordinance to be published in the Reno Evening Gazette for a period of one week.
