AN ORDINANCE AMENDING WASHOE COUNTY ORDINANCE NOS. 84, 177 AND 223 TO ELIMINATE THE REFUNDING OF FEES OF LESS THAN \$50.00.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.
Amends Washoe County Ordinance No. 84, Exhibit A, Section 4, by adding Article D, which reads as follows:

D. Fees Not Refundable - Fees of less than \$50.00 shall not be refunded.

SECTION 2.

Amends Washoe County Ordinance No. 177, Article 7, Section A, by adding Subsection 6, which reads as follows:

6. Fees Not Refundable - Fees of less than \$50.00 shall not be refunded.

SECTION 3.

Amends Washoe County Ordinance No. 223, Exhibit A, Part II, Chapter 3, Section A, Section 306, by adding Subsection (k), which reads as follows:

(k) Fees Not Refundable - Fees of less than \$50.00 shall not be refunded.
