Notice is hereby given that Bill No. 413, adopting Ordinance No. 250, entitled "An Ordinance making unlawful the failure, refusal, or neglect to remove or cause to be removed all ice and snow resulting from a storm from sidewalks utilized by the public in the unincorporated portion of Washoe County; describing penalties for violation thereof; and providing other matters properly relating thereto," was adopted on January 15, 1975 by Commissioners Scott, Grow, Rusk, Nelson and Gaunt all voting aye.

SUMMARY: Requires removal of snow and ice from sidewalks used by the public in the unincorporated portion of Washoe County within twenty-four hours after the cessation of a storm.

BILL NO. 413

ORDINANCE NO. 250

AN ORDINANCE MAKING UNLAWFUL THE FAILURE, REFUSAL, OR NEGLECT TO REMOVE OR CAUSE TO BE REMOVED ALL ICE AND SNOW RESULTING FROM A STORM FROM SIDEWALKS UTILIZED BY THE PUBLIC IN THE UNINCORPORATED PORTION OF WASHOE COUNTY; DESCRIBING PENALTIES FOR VIOLATION THEREOF; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

SECTION 1. Purpose.

The purpose of this ordinance is to safeguard the public health, safety, and general welfare by requiring the removal of snow and ice from sidewalks utilized by the public in the unincorporated area of Washoe County.

SECTION 2. Removal of Snow and Ice from Sidewalks Utilized by Public.

It shall be unlawful for any person, firm, partnership, association, company, or corporation owning, having charge or control of, or occupying a property, building, lot, part of lot, land, or real estate open to public use or abutting on any street or roadway in the unincorporated area of Washoe County to fail, refuse, or neglect to remove or cause to be removed, all ice or snow resulting from a storm, from the sidewalk or sidewalks in front of such property, building, lot, part of lot, land, or real estate.

SECTION 3. Penalty.

Any person, firm, partnership, association, company, or corporation who shall violate any of the provisions of this ordinance shall be guilty of a misdemeanor punishable by a fine not to exceed \$500.

SECTION 4. Validity.

If any provision, or part thereof, of this ordinance shall be declared by a court of competent jurisdiction to be illegal or unconstitutional, it shall in no way effect the remainder of this ordinance, or any sections thereof, it being intended that the remainder shall remain in full force and effect.


SECTION 5.

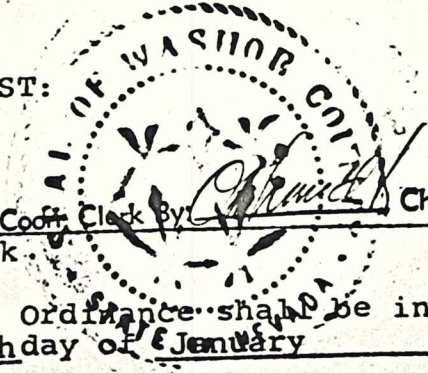
