AN ORDINANCE AMENDING EXHIBIT "A" TO ORDINANCE NO. 193 TO PROVIDE THAT THE PROVISIONS OF THE UNIFORM FIRE CODE SHALL BE ENFORCED BY THE FIRE CHIEF OF AN ORGANIZED FIRE PROTECTION DISTRICT IN THOSE AREAS OF WASHOE COUNTY LYING WITHIN THE BOUNDARIES OF SUCH FIRE PROTECTION DISTRICT, AND BY THAT PERSON OR ENTITY THE BOARD OF COUNTY COMMISSIONERS SHALL DESIGNATE BY CONTRACT OR OTHERWISE, IN THE UNINCORPORATED AREAS OF WASHOE COUNTY WHICH DO NOT LIE WITHIN AN ORGANIZED FIRE PROTECTION DISTRICT; DESCRIBING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.
The first paragraph of Exhibit "A" of Washoe County Ordinance No.
193 is hereby amended to read as follows:

The Uniform Fire Code shall be enforced in the unincorporated areas of Washoe County which do not lie within an organized fire protection district by that person or entity the Board of County Commissioners of Washoe County, Nevada shall designate by contract or otherwise. In the unincorporated areas of Washoe County not lying within an organized fire protection district, the person or entity so designated by the Board of County Commissioners, and his or its authorized representatives, shall be the "fire chief" or "chief" as those terms and like terms are used in the 1971 Edition of the Uniform Fire Code. The Uniform Fire Code shall be enforced in the areas of Washoe County which lie within the boundaries of an organized fire protection district by the fire protection district. In those areas of Washoe County lying within the boundaries of an organized fire protection district, the fire chief of such district or his authorized representatives shall be the "fire chief" or "chief" as those terms and like terms are used in the 1971 Edition of the Uniform Fire Code. All references in the Uniform Fire Code to "municipality," "city" and the like shall be construed to mean the County of Washoe. Wherever the word "jurisdiction" is used in the Uniform Fire Code, it shall be held to mean the unincorporated area of the County of Washoe, State of Nevada.

SECTION 2.
This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
