Notice is hereby given that Bill No. 448, Ordinance
No. 284, smending Ordinance No. 31, entitled "An Ordinance to
fix, impose and collect a license tax on all character of lawful
trades, callings, industries, occupations, professions and business conducted in the County of Washoe, outside of the limits of
incorporated cities and towns in Washoe County; fixing a penalty
for the violation thereof; and repealing all ordinances and parts
of ordinances in conflict therewith; providing for the licensing
for sale at retail of shells, cartridges or bombs containing or
capable of emitting tear gas, or any weapon designated for the
use of such shell, cartridge or bomb," was adopted on September
15, 1975 by Commissioners Scott, Grow, Rusk, Nelson and Gaunt

ORDINANCE NO. 284

AN ORDINANCE TO FIX, IMPOSE AND COLLECT A LIGENSE TAX ON ALL CHARACTER OF LAWFUL TRADES, CALLINGS, INDUSTRIES, OCCUPATIONS, PROFESSIONS AND BUSINESS CONDUCTED IN THE COUNTY OF WASHOE, OUTSIDE OF THE LIMITS OF INCORPORATED CITIES AND TOWNS IN WASHOE COUNTY; FIXING A PENALTY FOR THE VIOLATION THEREOF; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH; PROVIDING FOR THE LICENSING FOR SALE AT RETAIL OF SHELLS, CARTRIDGES OR BOMBS CONTAINING OR CAPABLE OF EMITTING TEAR GAS, OR ANY WEAPON DESIGNATED FOR THE USE OF SUCH SHELL, CARTRIDGE OR BOMB.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.
The title of Washoe County Ordinance No. 31 is hereby amended to read as follows:

AN ORDINANCE TO FIX, IMPOSE AND COLLECT A LICENSE TAX ON ALL CHARACTER OF LAWFUL TRADES, CALLINGS, INDUSTRIES, OCCUPATIONS, PROFESSIONS AND BUSINESS CONDUCTED IN THE COUNTY OF WASHOE OUTSIDE OF THE LIMITS OF INCORPORATED CITIES AND TOWNS IN WASHOE COUNTY; FIXING A PENALTY FOR THE VIOLATION THEREOF; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH; PROVIDING FOR THE LICENSING FOR SALE AT RETAIL OF SHELLS, CARTRIDGES OR BOMBS CONTAINING OR CAPABLE OF EMITTING TEAR GAS, OR ANY WEAPON DESIGNATED FOR THE USE OF SUCH SHELL, CARTRIDGE OR BOMB WITHIN THE COUNTY OF WASHOE.

SECTION 2.
Section 1 of Washoe County Ordinance No. 31 is hereby amended to read as follows:

SECTION 1. License required for engaging in business. It shall be unlawful for any person or persons, firm, association or corporation to engage in any business, trade, calling, industry, occupation, or profession, with the exception of such businesses licensed under Section 27 of this ordinance, outside of the limits of incorporated cities and towns in the County of Washoe without first procuring a license therefor from the County of Washoe and without first paying a license tax therefor to the County of Washoe. It shall be unlawful for any person or persons, firm, association or corporation to engage in any business governed by Section 27 of this ordinance in Washoe County without first procuring a license therefor from the Sheriff of Washoe County and without first paying a license fee to the County of Washoe as required under Section 27 of this ordinance.

SECTION 3.
This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
