ORDINANCE NO. 3/0

AN ORDINANCE AMENDING AN ORDINANCE PROHIBITING THE DISCHARGE OF FIREARMS ON OR ACROSS COUNTY ROADS; PROHIBITING THE DISCHARGE OF CERTAIN DESCRIBED FIREARMS WITHIN 5,000 FEET OF A DWELLING IN THE UNINCORPORATED AREA OF THE COUNTY; PROHIBITING THE DISCHARGE OF CERTAIN DESCRIBED FIREARMS WITHIN 1,000 FEET OF A DWELLING IN THE UNINCORPORATED AREA OF THE COUNTY; PROHIBITING THE DISCHARGE OF FIREARMS WITHIN A DEFINED CONGESTED AREA IN THE UNINCORPORATED AREA OF THE COUNTY; REQUIRING REASONABLE POSTING BY THE COUNTY OF CONGESTED AREAS IN WHICH THE DISCHARGE OF FIREARMS IS PROHIBITED; PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

County Ordinance No. 136 is hereby amended to read as follows:

SECTION 7.
Section 3 of Washoe County Ordinance No. 136 is hereby amended by the addition of subsection F to read as follows:

F. That area designated as Section 3-F on the accompanying map attached hereto and incorporated herein, more specifically described as:

All that certain area within the following described parcels of land within the unincorporated area of Washoe County: All of Sections 4 and 9, the west one-half (W 1/2) of Section 10 lying northerly of U. S. Interstate Highway 80, the northwest one-quarter (NW 1/4) of the northwest one-quarter (NW 1/4) of Section 15, and the northeast one-quarter (NE 1/4) of Section 16; all of the above described parcels of land lying and being in T.19N., R.21E., M.D.B.&M.

SECTION 8.
The maps to accompany Washoe County Ordinance No. 136, presently designated as sheet 1 of 3, sheet 2 of 3, and sheet 3 of 3 are hereby deleted from said ordinance and replaced with the maps to accompany Washoe County Ordinance No. 136 designated as sheet 1 of 5, sheet 2 of 5, sheet 3 of 5, sheet 4 of 5, and sheet 5 of 5, attached hereto.

SECTION 9. This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.




