ORDINANCE NO. 315

AN ORDINANCE TO AMEND WASHOE COUNTY ORDINANCE NO. 229 ENTITLED "AN ORDINANCE REGULATING THE USE OF COUNTY PARK SYSTEM FACILITIES; DESIGNATING THE WASHOE COUNTY PARKS AND RECREATION DEPARTMENT TO ADMINISTER THE SYSTEM; PERMITTING PROMULGATION OF RULES AND REGULATIONS TO SUPPLEMENT THE PROVISIONS OF THE ORDINANCE; PROVIDING FOR PAYMENT OF FEES; PROVIDING PROHIBITIONS AND A PENALTY; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

SECTION 1. Section 28 of Ordinance No. 229 is hereby amended to read as follows:

SECTION 28.

- A. Except as provided in paragraphs C and D of this section, fees for the use of camping facilities are due and payable daily. The daily fee covers use of facilities until the vacating time of 2:00 p.m. of the following day. Occupants shall vacate campsites by removing their personal property therefrom prior to 2:00 p.m. if the applicable fee has not been paid, or if the time limit for occupancy has expired.
- B. Overnight (daily) campground fees shall be charged at the rate of \$3 per campsite.
- C. A yearly rate for overnight camping is hereby established, with tickets to be sold at the rate of \$20 per family and \$15 per senior family, sold on a calendar-year basis.
- D. A group camping rate is hereby established, to be charged at the rate of \$3 for the first 20 persons. For group camping in self-contained recreational vehicles there shall be a charge of \$1 per vehicle, with a 3-day stay limit.
- E. An envelope-type collection system shall be instituted, similar to systems in use by the Nevada State Parks System and the United States Forest Service, to be utilized by Washoe County residents only.

SECTION 2. This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
