AN ORDINANCE TO AMEND "AN ORDINANCE CREATING THE GENERAL SERVICES DEPARTMENT; PROVIDING FOR THE POSITION OF DIRECTOR OF GENERAL SERVICES; SPECIFYING POWERS AND DUTIES OF THE DEPARTMENT AND ITS OFFICERS AND EMPLOYEES; AMENDING ORDINANCE NO. 204 BY ABOLISHING THE GENERAL SERVICES DIVISION IN THE DEPARTMENT OF PUBLIC WORKS; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO."

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 2 of Washoe County Ordinance No. 285 is hereby amended to read as follows:

SECTION 2. Creation of position of Director of General Services; appointment of department personnel.

- A. The position of Director of General Services is hereby created. The director shall be appointed by the Board of County Commissioners, upon recommendation of the County Manager.
- B. The Director may appoint the head of one of the divisions created pursuant to the provisions of Section 4 as Assistant Director of General Services.
- C. The Director shall appoint, pursuant to the provisions of any county ordinance regulating county personnel, such technical, clerical and operational staff as the execution of his duties and the operation of his department may require.

SECTION 2. This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
