BILL NO. 510

ORDINANCE NO. 342

AN ORDINANCE TO PROTECT THE PUBLIC HEALTH, PROPERTY AND SAFETY OF THE CITIZENS OF WASHOE COUNTY, STATE OF NEVADA, BY PROVIDING MINIMUM STANDARDS IN REGARD TO TRAFFIC CONTROL; PROVIDING PENALTIES FOR NONCOMPLIANCE WITH THE PROVISIONS HEREOF; REPEALING ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

The Nevada Traffic Control Manual, 1976 Edition, published by the State of Nevada Department of Highways, and the Manual on Uniform Traffic Control Devices for Streets and Highways, 1971 Edition, adopted and published by the U. S. Department of Transportation Federal Highway Administration, copies of which are placed on file in the Office of the County Clerk of Washoe County, Nevada, shall be and hereby are adopted by reference, incorporated herein, and made a part hereof, and shall regulate all matters contained therein.

SECTION 2.

Any person who violates any of the sections or provisions of this ordinance is guilty of a misdemeanor and upon conviction shall be punished by imprisonment in the County Jail for a term not to exceed 6 months or by a fine not to exceed \$500, or by both fine and imprisonment.

SECTION 3.

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4.

This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.

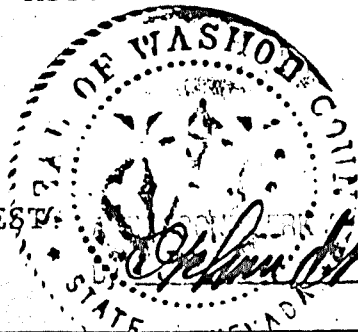
