NOTICE OF COUNTY ORDINANCE
Notice is hereby given that Bill No. 514, Ordinance No. 345, amending Ordinance No. 221, entitled "An Ordinance designating congested areas within the unincorporated area of Washoe County for purposes of animal control; prohibiting animals trespassing on private residential property or County property within congested areas; providing for the impounding of animals found in violation of the provisions of this ordinance; providing regulations of impounding, destruction or auction, and release of impounded animals; provides for impounding of livestock in the County which are endangering private or public property, public safety, themselves, or other animals; providing penalties for the non-compliance of the provisions hereof; and other matters properly relating thereto" by designating the Comstock Drive-Valley Road area as a congested area, was adopted on June 7, 1977 by Commissioners Scott, Rusk, Gault and Farr.

ORDINANCE NO. 345

AN ORDINANCE AMENDING "AN ORDINANCE DESIGNATING CONGESTED AREAS WITHIN THE UNINCORPORATED AREA OF WASHOE COUNTY FOR PURPOSES OF ANIMAL CONTROL; PROHIBITING ANIMALS TRESPASSING ON PRIVATE RESIDENTIAL PROPERTY OR COUNTY PROPERTY WITHIN CONGESTED AREAS; PROVIDING FOR THE IMPOUNDING OF ANIMALS FOUND IN VIOLATION OF THE PROVISIONS OF THIS ORDINANCE; PROVIDING REGULATIONS OF IMPOUNDING, DESTRUCTION OR AUCTION, AND RELEASE OF IMPOUNDED ANIMALS; PROVIDES FOR IMPOUNDING OF LIVESTOCK IN THE COUNTY WHICH ARE ENDANGERING PRIVATE OR PUBLIC PROPERTY, PUBLIC SAFETY, THEMSELVES, OR OTHER ANIMALS; PROVIDING PENALTIES FOR THE NONCOMPLIANCE OF THE PROVISIONS HEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO" BY DESIGNATING THE COMSTOCK DRIVE-VALLEY ROAD AREA AS A CONGESTED AREA.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.

Section 8 of Washoe County Ordinance No. 211 is hereby amended by adding a new paragraph Y, which paragraph shall read as follows (all other paragraphs in said Section 8 remaining the same):

Y. Comstock Drive-Valley Road Area

All that certain area lying outside of the incorporated city limits of the City of Reno within the following described lands: All of Section 35, Easterly of North Virginia Street, and the West one-half (W 1/2) of Section 36, T.20N., R.19E., M.D.B.&M.

SECTION 2. Effective date.

This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.

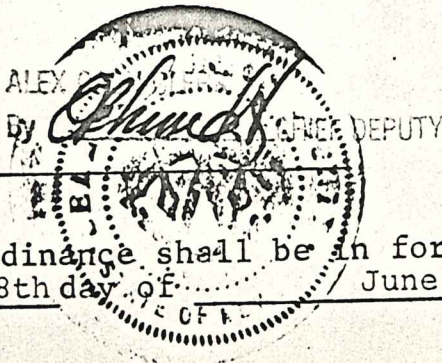
