BILL NO. 526

ORDINANCE NO. 358

AN ORDINANCE ESTABLISHING CERTAIN PROCEDURES FOR THE DEVELOPMENT OF THE COUNTY BUDGET; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Short Title.

This Ordinance, enacted pursuant to the authority contained in NRS 354.588 shall be known as the Budget Ordinance.

SECTION 2. Purposes.

The Board of County Commissioners declares that the purposes of this Ordinance are to:

- A. Establish methods and procedures for the development, presentation, adoption, administration and evaluation of departmental budget requests and the county budget.
- B. Enable the county to make financial plans for both current and capital expenditure programs and to establish program priorities for the expenditure of public funds.
- C. Provide for estimation and determination of revenues, expenditures and tax levies.
- D. Provide for the control of revenues and expenditures in order to promote prudence and efficiency in the expenditure of public funds.
- E. Enable the citizens of Washoe County to be apprised of the financial preparations, plans, policies and administration of the county.

SECTION 3. Responsibility for Budget Development.

- A. The County Manager is authorized and directed to develop the annual budget for approval by the Board of County Commissioners in accordance with the provisions of Chapter 354 of the Nevada Revised Statutes.
 - (1) The County Manager is authorized and directed to obtain the information in such form as he may deem necessary or desirable for the budget preparation and development.
 - (2) The County Manager or his designees shall meet with representatives of the several county departments for the purpose of formulating the County Manager's budget recommendations to the Board of County Commissioners.

- B. Prior to the adoption of a final budget, the Board of County Commissioners shall hold one or more public hearings for the purpose of obtaining information and recommendations from department heads and other interested persons regarding departmental programs and budget proposals.
- C. It is the duty of each department head to insure that his representatives furnish, in a timely fashion, such information as the County Manager may deem necessary to achieve the purposes of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication pursuant to NRS 244.100.
