AN ORDINANCE INITIATING PROCEEDINGS FOR THE MERGER OF WASHOE COUNTY SEWER IMPROVEMENT DISTRICT NO. 1 INTO THE INCLINE VILLAGE GENERAL IMPROVEMENT DISTRICT, PROVIDING FOR A HEARING THEREON, PROVIDING FOR THE GIVING OF NOTICE OF SAID HEARING AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

WHEREAS, the County of Washoe, in the State of Nevada, is a county created and operating under the laws of the State of Nevada;

WHEREAS, the Board of County Commissioners of Washoe County (herein sometimes designated as the "Board") is authorized and empowered to initiate proceedings for the merger of a local improvement district into another existing unit of government;

WHEREAS, there has been presented to and examined by this Board a duly certified copy of a resolution of the Board of Directors of the Washoe County Sewer Improvement District No. 1 requesting this Board to initiate proceedings for the merger of such District into the Incline Village General Improvement District and in said resolution said Board further states that said District will undertake and complete advance refunding proceedings and enter into all necessary and appropriate escrow agreements and related contracts with respect to its General Obligation Sewer Bonds of 1971;

WHEREAS, there has been presented to and examined by this Board a certified copy of a resolution of the Board of Trustees of the Incline Village General Improvement District wherein said Board of Trustees requests that this Board initiate such merger proceedings and said Board states that such district will assume all outstanding indebtedness and bonds of the Washoe County Sewer Improvement District No. 1 and in said resolution said Board further states that it will assume all of the rights, duties and obligations with respect to the advance refunding, escrow agreements and related contracts of said Washoe County Sewer Improvement District No. 1 regarding its General Obligation Sewer Bonds of 1971; and

WHEREAS, in said resolution the Board of Trustees of the Incline Village General Improvement District further states that said District can more effectively perform the services heretofore provided by the Washoe County Sewer Improvement District No. 1;

NOW, THEREFORE;

## SECTION 1.

This Board does hereby initiate proceedings for the merger of the Washoe County Sewer Improvement District No. 1 into the Incline Village General Improvement District pursuant to NRS 309.500, et seq., and NRS 318.490 to 318.510, inclusive.

### SECTION 2.

It is hereby found and determined that:

- A. All outstanding indebtedness and bonds of all kinds, including all rights, duties and obligation with respect to the advance refunding of the General Obligation Sewer Bonds of 1971, of the Washoe County Sewer Improvement District No. 1 will be assumed by the resulting merger into Incline Village General Improvement District.
- B. The services heretofore provided by the Washoe County Sewer Improvement District No. 1 can be more effectively performed by the Incline Village General Improvement District.

### SECTION 3.

This Board deems such merger to be in the best interest of the County of Washoe, Washoe County Sewer Improvement District No. 1 and the Incline Village General Improvement District.

### SECTION 4.

This Board hereby fixes Tuesday, the 16th day of May, 1978, at the hour of 1:30 o'clock p.m., in the Chambers of this Board, 1200 Mill Street, Reno, Nevada, as the time and place when and where the Board will hold a hearing on such merger and when and where all persons interested therein may be heard.

## SECTION 5.

Any taxpaying elector within the Washoe County Sewer Improvement District No. 1, or any person who owns property which is located within the Incline Village General Improvement District, may, on or before the date fixed for hearing, protest such merger by written protest filed with the Washoe County Clerk at or before the time fixed for the hearing.

### SECTION 6.

The County Clerk shall give notice of the adoption of this ordinance, of the determination of this Board that the Washoe County Sewer Improvement District No. 1 should be merged into the Incline Village General Improvement District and of the time and place for hearing on such merger, which notice shall be by publication and mailing:

- A. The notice by publication shall set forth the foregoing and said notice shall be published in the Nevada State Journal, a newspaper of general circulation in Washoe County Sewer Improvement District No. 1, and in the Incline Village General Improvement District, such publication to be once a week for three consecutive weeks, the first of which shall be at least 15 days prior to the date fixed for said hearing.
- B. The notice of mailing containing the foregoing information shall be addressed to the last known owner or owners of all real property within Washoe County Sewer Improvement District No. 1 and within the Incline Village General Improvement District, to his or their last known address or addresses, such addresses and owners being those appearing on the real property assessment rolls for general (ad valorem)

taxes of Washoe County and from such other sources as the Secretary of each District deems reliable, said notice shall be given by a single mailing by first class mail (or its equivalent), postage prepaid, by deposit in the United States mails, at least 15 days prior to the date of the hearing.

### SECTION 7.

The County Clerk shall cause this ordinance to be published by title, together with a separate statement to the effect that typewritten copies of the ordinance are available for inspection at the office of the County Clerk by all interested persons together with the names of the County Commissioners voting for and against its passage in the Nevada State Journal, a newspaper of general circulation printed and published in the County of Washoe, being the newspaper which is most likely to give notice to persons interested herein, at least once a week for a period of two weeks before this ordinance becomes effective.

## SECTION 8.

The County Clerk shall forthwith cause a copy of this ordinance to be recorded together with the affidavits of publication by the publisher in a book kept for that purpose.

## SECTION 9.

The County Clerk shall forthwith cause a copy of this ordinance to be certified to the Board of Directors of the Washoe County Sewer Improvement District No. 1 and to the Board of Trustees of the Incline Village General Improvement District.
