SUMMARY: Amends Washoe County Ordinance No. 221 by removing minimum amount for which livestock may be sold at public auction; adds a designated area as a congested area within the terms of this ordinance; amends penalty provisions; and authorizes Animal Control Officer to issue oral or written warnings under certain conditions.

AN ORDINANCE AMENDING "AN ORDINANCE DESIGNATING CONGESTED AREAS WITHIN THE UNINCORPORATED AREA OF WASHOE COUNTY FOR PURPOSES OF ANIMAL CONTROL; PROHIBITING ANIMALS TRESPASSING ON PRIVATE RESIDENTIAL PROPERTY OR COUNTY PROPERTY WITHIN CONGESTED AREAS; PROVIDING FOR THE IMPOUNDING OF ANIMALS FOUND IN VIOLATION OF THE PROVISIONS OF THIS ORDINANCE; PROVIDING REGULATIONS OF IMPOUNDING, DESTRUCTION OR AUCTION AND RELEASE OF IMPOUNDED ANIMALS; PROVIDES FOR IMPOUNDING OF LIVESTOCK IN THE COUNTY WHICH ARE ENDANGERING PRIVATE OR PUBLIC PROPERTY, PUBLIC SAFETY, THEMSELVES, OR OTHER ANI-MALS; PROVIDING PENALTIES FOR THE NONCOMPLIANCE OF THE PROVISIONS HEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO" BY REMOVING MINIMUM AMOUNT FOR WHICH LIVESTOCK MAY BE SOLD AT PUBLIC AUCTION; ADDING AN AREA AS A DEFINED CONGESTED AREA IN THE UNINCORPORATED AREA OF THE COUNTY WITHIN THE MEANING OF THIS ORDINANCE; AMENDING PENALTY PROVISIONS; AND AUTHORIZING ANIMAL CONTROL OFFICER TO ISSUE ORAL OR WRITTEN WARNINGS UNDER CERTAIN CONDITIONS.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

SECTION 1.
Section 6 of Washoe County Ordinance No. 221 is hereby amended to read as follows:

SECTION 6. Notice of Impoundment; Disposition of Unclaimed Livestock.

- A. Where the identity of the owner of impounded livestock is known, such owner shall be given written notice of the impoundment. Oral notice may be given in addition to written notice. Five (5) days after written notice is mailed, the impounded livestock may be destroyed in a humane manner under the direction of the Poundkeeper if said livestock remains unclaimed and unredeemed (provided, however, any such unredeemed livestock authorized for destruction may be sold at public auction or given to a County agency pursuant to such guidelines as the Board of County Commissioners of Washoe County may hereinafter enact).
- B. Where the identity of the owner of impounded livestock is unknown, notice shall be published once a week for two consecutive weeks in a newspaper published at the County seat of Washoe County, stating:
 - 1. The kind of livestock impounded:
 - 2. The place of impoundment;
 - 3. The number of livestock impounded;
 - 4. The general area where the impounded livestock was taken into custody; and

5. The description of each such animal impounded including all brands and marks, and to the extent known or reasonably ascertainable, the sex, age, weight, color and kind of each animal so impounded.

This same information shall be forwarded by mail to the Department of Agriculture within five (5) days after the livestock is first taken up.

Five (5) days after the last date of publication of notice, the impounded livestock may be destroyed in a humane manner under the direction of the Poundkeeper if said livestock remains unclaimed and unredeemed.

C. Any unclaimed and unredeemed livestock authorized for destruction may be sold at public auction or given to a County agency pursuant to such guidelines as the Board of County Commissioners of Washoe County may adopt.

SECTION 2.

Section 8 of Washoe County Ordinance No. 221 is hereby amended by adding Paragraph Z to read as follows:

SECTION 8. Determination of Congested Area.
The following described areas within the unincorporated area of Washoe County are hereby determined to be congested areas for the purpose of this ordinance.

SECTION 3.
Section 9 of Washoe County Ordinance No. 221 is hereby amended to read as follows:

SECTION 9. Penalties.

Any person violating any of the previsions of this ordinance shall be guilty of a misdemeanor and upon

conviction thereof shall be punished by a fine of not less than Twenty-Five Dollars (\$25.00) nor more than Five Hundred Dollars (\$500.00). For failure to appear in the proper court to answer to such misdemeanor citation, such person failing to appear shall be punished by a fine of not less than Twenty-Five Dollars (\$25.00) nor more than Five Hundred Dollars (\$500.00). For any second conviction for violation of the same provision of this ordinance, such person violating that provision shall be punished by a fine of not less than Fifty Dollars (\$50,00) nor more than Five Hundred Dollars (\$500.00).

SECTION 4.

Washoe County Ordinance No. 221 is hereby amended by adding a new Section 10 to read as follows:

SECTION 10.

The Animal Control Officer may issue an oral or written warning to any person suspected of violating any of the provisions of this ordinance. The warning may precede or be issued in lieu of a written citation.

SECTION 5.

Existing Sections 10 to 12, inclusive, of Washoe County Ordinance No. 221 shall be renumbered as Sections 11 to 13, inclusive.

SECTION 6.

This ordinance shall take effect after its proposal, passage and publication as prescribed by NRS 244.100.
