NOTICE OF COUNTY ORDINANCE

Notice is hereby given that Bill No. 543, Ordinance No. 373, an ordinance amending Washoe County Ordinance No. 226, entitled "AN ORDINANCE PROVIDING FOR THE LICENSING AND INOCULATION AGAINST RABIES OF DOGS IN DESIGNATED CONGESTED AREAS OF THE UNINCORPORATED AREA OF WASHOE COUNTY; PROVIDES FOR SPECIAL PERMITS TO MAINTAIN IN EXCESS OF THREE DOGS; PROHIBITS DOGS RUNNING AT LARGE OR TRESPASSING ON PRIVATE PROPERTY; PROVIDES FOR QUARANTINE OF BITING ANIMALS; PROVIDES FOR THE DESIGNATION OF A POUND KEEPER AND THE IMPOUNDMENT OF ANIMALS FOUND IN VIOLATION OF THE PROVISIONS OF THIS ORDINANCE; PROVIDING FOR REGULATIONS FOR IMPOUNDMENT, DESTRUCTION AND RELEASE OF ANIMALS; PROHIBITS THE KEEPING OF NOISY ANIMALS; PROVIDES FOR THE IMPOUNDING OF ALL DOGS ENDANGERING PRIVATE OR PUBLIC PROPERTY, PUBLIC SAFETY, THEMSELVES, OR OTHER ANIMALS; PROVIDES PENALTIES FOR NON-COMPLIANCE WITH THE PROVISIONS HEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO," was adopted on April 11, 1978 by Commissioners Rusk, Nelson, Farr, Stoess and Brown.

SUMMARY

Amends Washoe County Ordinance No. 226 by removing exception to requirement of special permit to keep and maintain more than three dogs over the age of six months; provides for notification of certain persons by Animal Control Officer when application for special permit is made; provides for appeal by certain persons when application for special permit is approved; requires compliance with Section 8 of that ordinance within 30 days of date on which a special permit is disapproved; provides for placement of biting animal in quarantine for such time as may be ordered by Animal Control Officer; adds a designated area as a congested area within the terms of this ordinance; and authorizes Animal Control Officer to issue oral or written warnings under certain conditions.

AN ORDINANCE AMENDING "AN ORDINANCE PROVIDING FOR THE LICENSING AND INOCULATION AGAINST RABIES OF DOGS IN DESIG-NATED CONGESTED AREAS OF THE UNINCORPORATED AREA OF WASHOE COUNTY; PROVIDES FOR SPECIAL PERMITS TO MAINTAIN IN EXCESS OF THREE DOGS; PROHIBITS DOGS RUNNING AT LARGE OR TRESPASS-ING ON PRIVATE PROPERTY; PROVIDES FOR THE QUARANTINE OF BITING ANIMALS; PROVIDES FOR THE DESIGNATION OF A POUND-KEEPER AND THE IMPOUNDMENT OF ANIMALS FOUND IN VIOLATION OF THE PROVISIONS OF THIS ORDINANCE; PROVIDING FOR REGULATIONS FOR IMPOUNDMENT, DESTRUCTION AND RELEASE OF ANIMALS; PRO-HIBITS THE KEEPING OF NOISY ANIMALS; PROVIDES FOR THE IMPOUNDING OF ALL DOGS ENDANGERING PRIVATE OR PUBLIC PROP-ERTY, PUBLIC SAFETY, THEMSELVES, OR OTHER ANIMALS; PROVIDES PENALTIES FOR NONCOMPLIANCE WITH THE PROVISIONS HEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO" BY REMOVING THE EXCEPTION TO THE REQUIREMENT OF A SPECIAL PERMIT TO KEEP AND MAINTAIN MORE THAN THREE DOGS OVER THE AGE OF SIX MONTHS; PROVIDING FOR NOTIFICATION OF CERTAIN PERSONS BY THE ANIMAL CONTROL OFFICER WHEN APPLICATION FOR A SPECIAL PERMIT IS MADE; PROVIDING FOR APPEAL BY CERTAIN PERSONS WHEN AN APPLICATION FOR A SPECIAL PERMIT IS APPROVED; REQUIRING COMPLIANCE WITH SECTION 8 OF WASHOE COUNTY ORDINANCE NO. 226 WITHIN 30 DAYS OF THE DATE ON WHICH A SPECIAL PERMIT IS DISAPPROVED; PROVIDING FOR PLACEMENT OF BITING ANIMAL IN QUARANTINE FOR SUCH TIME AS MAY BE ORDERED BY THE ANIMAL CONROL OFFICER; ADDING AN AREA AS A DEFINED CONGESTED AREA IN THE UNINCORPORATED AREA OF THE COUNTY WITHIN THE MEANING OF THIS ORDINANCE; AND AUTHORIZING THE ANIMAL CONTROL OFFICER TO ISSUE ORAL OR WRITTEN WARNINGS UNDER CERTAIN CONDITIONS.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DO ORDAIN:

SECTION 1.
Section 8 of Washoe County Ordinance No. 226 is hereby amended to read as follows:

SECTION 8. Permit to Keep More Than Three (3) Dogs. No person shall keep more than three (3) dogs over six (6) months of age at any place, or on any premises, or in any residence located within a congested area in the unincorporated area of Washoe County, within 200 feet of any other dwelling house, used or occupied by human beings other than the owner of such dogs, without first obtaining a special permit from the County therefor, as hereinafter provided.

SECTION 2.

Section 9 of Washoe County Ordinance No. 226 is hereby amended to read as follows:

SECTION 9. Permit Procedure.

- A. Application for a special permit to keep and maintain more than three (3) dogs over the age of six (6) months shall be made to the Animal Control Officer. The application shall specify the number of dogs for which a special permit is requested. Upon receipt of the application, the Animal Control Officer shall notify each person residing within 200 feet of the location at which the dogs will be kept or maintained that an application has been received for a special permit. The Animal Control Officer shall also investigate the premises for which the application is made, approve the application and issue a special permit if he finds that:
 - (1) Keeping the dogs at the location specified in the application will not violate any ordinance, rule or regulation of Washoe County or the District Health Officer or any law of the State of Nevada;
 - (2) The premises contain an adequate enclosure for keeping the dogs;
 - (3) Maintenance of the dogs will not endanger the peace, health or safety of persons residing in Washoe County;
 - (4) The premises are capable of being maintained in a clean and sanitary condition, and any dog therein will not be subject to neglect, cruelty or abuse;
 - (5) Keeping and maintenance of the dogs will not constitute a nuisance as defined in NRS 40.140.
- B. Within ten (10) days following the inspection of the premises, the Animal Control Officer shall approve, conditionally approve, or disapprove the application for the special permit. If the application is conditionally approved, the Animal Control Officer shall specify in writing those conditions upon which the special permit will be issued.
- C. If the applicant or any person notified pursuant to Paragraph A of this section is dissatisfied with any decision of the Animal Control Officer, he may, within fifteen (15) days after the decision, appeal it to the Board of County Commissioners. The Board shall consider such evidence as is presented relating to the decision of the Animal Control Officer and may reverse, approve or modify the decision of the Animal Control Officer by a simple majority vote.
- D. If an application for a special permit is disapproved or the Board of County Commissioners reverses the decision of the Animal Control Officer to approve the permit, the applicant,

within 30 days of the disapproval or reversal, shall comply with the provisions contained in Section 8 of this ordinance.

E. Failure of the Animal Control Officer to render a decision within ninety (90) days from the date of application shall constitute approval of the application for a special permit.

SECTION 3.

Section 14 of Washoe County Ordinance No. 226 is hereby amended to read as follows:

SECTION 14. Impounding of Biting Animals.

- A. When any animal bites a human within the County, the owner of such animal shall immediately place the animal in quarantine, or the Animal Control Officer or any peace officer may seize such animal, whether on or off the owner's premises, and place the animal in quarantine for such period of time as may be ordered by the Animal Control Officer. The animal to be quarantined shall be placed in confinement with a licensed veterinarian in a veterinary hospital or other place of quarantine approved by the District Health Officer, and such quarantine shall be at the owner's expense.
- B. Any animal quarantined shall remain in quarantine for such period of time as the Animal Control Officer shall order, and such animal shall not be released until a written release is issued by the Animal Control Officer.
- C. The owner of any animal placed in quarantine shall present to the Animal Control Officer a written statement executed by a veterinarian licensed to practice in the State of Nevada that the animal has received inoculation for rabies.

SECTION 4.

Section 21 of Washoe County Ordinance No. 226 is hereby amended by adding Paragraph Y to read as follows:

SECTION 21. Determination of Congested Area.
The following described areas within the unincorporated area of Washoe County are hereby determined to be congested areas for the purpose of this ordinance.

SECTION 5.

Washoe County Ordinance No. 226 is hereby amended by adding a new Section 24 to read as follows:

SECTION 24. The Animal Control Officer may issue an oral or written warning to any person suspected of violating any of the provisions of this ordinance. The warning may precede or be issued in lieu of a written citation.

Existing Sections 24 to 27, inclusive, of Washoe County Ordinance No. 226 shall be renumbered as Sections 25 to 28, inclusive.

SECTION 7. This ordinance shall take effect after its proposal, passage and publication as prescribed by NRS 244.100.
