AN ORDINANCE AMENDING "AN ORDINANCE ESTABLISHING FEES FOR SOLEMNIZATION OF MARRIAGES BY THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES, AUTHORIZING THE HOURS OF OPERATION FOR THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES TO BE ESTABLISHED BY THE COMMISSIONER, PROVIDING FOR PAYMENT OF SALARIES TO EMPLOYEES OF THE OFFICE OF THE COMMISSIONER OF CIVIL MARRIAGES AND MARRIAGE LICENSE BUREAU FOR SUNDAYS AND HOLIDAYS AT THE SAME RATE AS OTHER COUNTY EMPLOYEES, AND OTHER MATTERS PROPERLY RELATING THERETO".

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1.
Section 2 of Washoe County Ordinance No. 182 shall be amended to read as follows:

The hours of operation for the Office of the Commissioner of Civil Marriages must be the same as the hours of the office in which marriage licenses are issued.

SECTION 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
