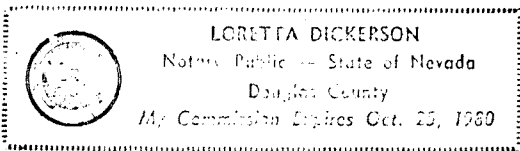

AN ORDINANCE REPEALING "AN ORDINANCE AUTHORIZING THE COUNTY CLERK TO CHARGE AND COLLECT AN ADDITIONAL FEE FOR MARRIAGE LICENSES ISSUED BEFORE OR AFTER REGULAR OFFICE HOURS. PROVIDING FOR THE PAYMENT THEREOF TO THE COUNTY GENERAL FUND AND OTHER MATTERS PROPERLY RELATING THERETO."

SECTION 1

Washoe County Ordinance No. 55 is hereby repealed.
