SUMMARY: Amends provisions of Ordinance No. 68 relating to eligibility for medical care.

BILL NO. 634 ORDINANCE NO. 463

AN ORDINANCE AMENDING AN ORDINANCE ENTITLED "AN ORDINANCE CREATING A COUNTY DEPARTMENT OF WELFARE; SETTING UP AN ADVISORY BOARD, DEFINING THE DUTIES OF THE ADVISORY BOARD, PROVIDING FOR THE APPOINTMENT OF A WELFARE DIRECTOR AND DEFINING THE DUTIES OF THE WELFARE DIRECTOR, PROVIDING STANDARDS FOR ELIGIBILITY FOR COUNTY MEDICAL CARE" BY AMENDING THE PROVISIONS PERTAINING TO ELIGIBILITY FOR MEDICAL CARE.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

ARTICLE 1. Article 6 of Washoe County Ordinance No. 68 is hereby amended to read as follows:

ARTICLE 6. Eligibility for Medical Care.

SECTION 1.

B. Income Test. A person does not have sufficient funds if his average net monthly income and number of persons dependent upon that income are as set forth in the following schedule:

No. of Persons Dependent Upon Income of Patient or Responsible Relative	Schedule of Monthly Net Income
1	Less than \$300
2	Less than \$375
3	Less than \$450
4	Less than \$525
5	Less than \$600
6	Less than \$675

For each additional person over 6 there shall be added \$75.00 to the above limit of income.

C. Computation of Income. For the purpose of the foregoing table, the following deductions shall be allowed.

Regular monthly payments on:

- 1. Existing medical bills.
- 2. Purchase of prosthetic devices prescribed by a physician.
- 3. Medical and hospital insurance premiums.
- 4. The cost of living away from home for any member of the family due to illness, to be allowed on an individual basis and calculated

upon the difference between the cost so incurred and the cost which would have been incurred if the person remained at home.

- 5. Alimony and child support, provided that such payment is paid to a person not included as one of the "persons dependent on income of patient or responsible relative" in the above table.
- 6. Funeral expenses not to exceed \$1,500 for any one funeral.
- 7. Necessary costs for child care required to maintain employment.
- 8. Necessary expenses of employment.
- 9. Involuntary deductions from income, such as income tax, social security contributions, and retirement fund payments.
- 10. For self-employed persons, deductions of expenses incurred in the conduct of business as allowed by Federal income tax laws.
- D. Other factors. If a person does not meet the income test, he may be eligible if it is determined by the Director that he does not have sufficient funds to pay for all or part of his medical care by reason of the following other factors:
 - 1. Nature of the disability. Effect of the disability, if any, on future income production.
 - 2. Estimated length of hospitalization.
 - 3. Estimated elapsed time before employed person may return to work.
