#### ORDINANCE NO. 414

AN ORDINANCE INITIATING PROCEEDINGS FOR THE MERGER OF THE SUN VALLEY WATER DISTRICT NO. 2 INTO THE SUN VALLEY WATER DISTRICT, PROVIDING FOR A HEARING THEREON, PROVIDING FOR THE GIVING OF NOTICE OF THE HEARING AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

WHEREAS, the County of Washoe, in the State of Nevada, is a county created and operating under the laws of the State of Nevada; and

WHEREAS, the Board of County Commissioners of Washoe County (herein sometimes designated as the "Board") is authorized and empowered to initiate proceedings for the merger of a local improvement district into another existing unit of government; and

WHEREAS, a majority of the members of the Board have determined that it would be in the best interests of the County of Washoe and Sun Valley Water District No. 2 that it be merged with the Sun Valley Water District; and

WHEREAS, the Board believes that the services of the Sun Valley Water District No. 2 can be more effectively performed by the Sun Valley Water District.

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE COUNTY OF WASHOE, IN THE STATE OF NEVADA, DO ORDAIN:

SECTION 1.
This Board does hereby initiate proceedings for the merger of the Sun Valley Water District No. 2 into the Sun Valley Water District pursuant to NRS 318.490 to 318.510, inclusive.

## <u>SECTION 2.</u> It is hereby found and determined that:

- (a) All outstanding indebtedness and bonds of all kinds of the Sun Valley Water District No. 2 have been paid or will be assumed by the Sun Valley Water District.
- (b) The services heretofore provided by the Sun Valley Water District No. 2 can be more effectively performed by the Sun Valley Water District.

SECTION 3. This Board deems such merger to be in the best interest of the County of Washoe, Sun Valley Water District No. 2 and the Sun Valley Water District.

This Board hereby fixes world, the 12 day of fixed, 1980, at the hour of 4:00 o'clock p.m., in the Chambers of this Board, 1205 Mill Street, Reno, Nevada, as the time and place when and where the Board will hold a hearing on such merger and when and where all persons interested therein may be heard.

SECTION 5.
Any person who owns property which is located within the Sun Valley Water District No. 2 may, on or before the date fixed for hearing, protest such merger by written protest filed with the Washoe County Clerk at or before the time fixed for the hearing.

SECTION 6.
The County Clerk shall give notice of the adoption of this ordinance, of the determination of this Board that the Sun Valley Water District No. 2 should be merged into the Sun Valley Water District, and of the time and place for hearing on such merger, which notice shall be by mailing.

The County Clerk shall cause this ordinance to be published by title, together with a separate statement to the effect that typewritten copies of the ordinance are available for inspection at the office of the County Clerk by all interested persons, together with the names of the County Commissioners voting for and against its passage in the Reno Evening Gazette , a newspaper of general circulation printed and published in the County of Washoe, being the newspaper which is most likely to give notice to persons interested herein, at least once a week for a period of two weeks before this ordinance becomes effective.

The County Clerk shall forthwith cause a copy of this ordinance to be recorded together with the affidavits of publication by the publisher in a book kept for that purpose.

The County Clerk shall forthwith cause a copy of this ordinance to be certified to the Board of Directors of the Sun Valley Water District No. 2 and to the Board of Trustees of the Sun Valley Water District.
