NOTICE OF COUNTY ORDINANCE
NOTICE IS HEREBY GIVEN that Bill No. 675, Ordinance No. 504, amending Ordinance No. 181, entitled, "An Ordinance regulating the design, quality of materials, construction, location, electrification, and maintenance of all signs and sign structures not located within a building in the unincorporated area of Washoe County; providing for the administration thereof, the licensing of firms and individuals who construct and/or place advertising displays, the establishment and collection of fees; further providing for the violation thereof; and other matters properly relating thereto" by imposing moratorium or restrictions on grate of building permits for off-premise and on-premise signs in Washoe County pending complete revision of sign code was adopted on September 22, 1981, by Commissioners Farr, Ferrari, Underwood, Brown and Williams.

SUMMARY: Amends Washoe County Ordinance No. 181 by imposing moratorium or restrictions on grant of building permits for off-premise and on-premise signs in Washoe County pending complete revision of sign code.

BILL NO. 675

ORDINANCE NO. 504

AN ORDINANCE AMENDING "AN ORDINANCE REGULATING THE DESIGN, QUALITY OF MATERIALS, CONSTRUCTION, LOCATION, ELECTRIFICATION, AND MAINTENANCE OF ALL SIGNS AND SIGN STRUCTURES NOT LOCATED WITHIN A BUILDING IN THE UNINCORPORATED AREA OF WASHOE COUNTY; PROVIDING FOR THE ADMINISTRATION THEREOF, THE LICENSING OF FIRMS AND INDIVIDUALS WHO CONSTRUCT AND/OR PLACE ADVERTISING DISPLAYS, THE ESTABLISHMENT AND COLLECTION OF FEES; FURTHER PROVIDING FOR THE VIOLATION THEREOF; AND OTHER MATTERS PROPERLY RELATING THERETO," BY IMPOSING MORATORIUM OR RESTRICTIONS ON GRANT OF BUILDING PERMITS FOR OFF-PREMISE AND ON-PREMISE SIGNS IN WASHOE COUNTY PENDING COMPLETE REVISION OF SIGN CODE.

WHEREAS, the Board of County Commissioners of Washoe County find and declare that the erection of outdoor advertising signs, displays or devices in areas adjacent to the public highways in the unincorporated area of County has been and continues to be a legitimate commercial use of private property; and

WHEREAS, recent complaints from Washoe County citizens concerning the large size and location of such advertising signs, displays and devices and the Board's own investigation require that substantial revision be made to the existing sign code; and

WHEREAS, the Board finds and declares that regulations must be adopted to:

1. Prevent unreasonable risks to its citizens resulting from the sheer size and location of such advertising signs, displays and devices;
2. Prevent the unreasonable distraction of operators of motor vehicles and to preserve the effectiveness of traffic lights, signs and signals; and
3. Improve the appearance of the unincorporated area of Washoe County by restricting construction of commercial signs which detract from the natural scenic beauty and aesthetic features of the area; and

WHEREAS, the Board has directed the Washoe County District Attorney's Office to revise the sign code in accordance with its findings and deems it in the public interest to restrict the issuance of sign permits pending that revision;

NOW, THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY
DO ORDAIN:

SECTION 1.

The Uniform Sign Code, 1976 Edition, is hereby amended in Washoe County's Ordinance 181 by adding a new section which shall read as follows:

"Notwithstanding any other provision of this Code, no permit authorizing the construction of an off-premise sign carrying commercial advertising shall be issued until Washoe County Ordinance 181 is revised or forty-five (45) days have elapsed, whichever is sooner."

SECTION 2.

The Uniform Sign Code, 1976 Edition, is hereby amended in Washoe County Ordinance 181, by adding a new provision which shall read as follows:

"Notwithstanding any provision of this Code to the contrary, advertising signs, displays or devices promoting a business, product or activity conducted or produced on the parcel, lot or commercial complex upon which the sign is to be located shall not exceed the size of two square feet per lineal foot of building frontage or four hundred square feet, whichever is less."

SECTION 3.

This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
