ORDINANCE NO. 5//

AN ORDINANCE AMENDING "AN ORDINANCE ADOPTING THE PROVISIONS OF STATE LAW FOR THE ESTABLISHMENT, MAINTENANCE AND OPERATION OF LAW LIBRARIES, SETTING FEES TO BE SET ASIDE ON THE COMMENCEMENT IN, OR REMOVAL TO, THE DISTRICT COURT OF WASHOE COUNTY OF ANY CIVIL ACTION, PROCEEDING OR APPEAL, AND AUTHORIZING THE BOARD OF TRUSTEES OF SAID LAW LIBRARY TO DO ALL THINGS NECESSARY TO ESTABLISH AND MAINTAIN SAID LIBRARY, AND OTHER MATTERS PROPERLY PERTAINING THERETO" BY INCREASING THE AMOUNT OF FILING FEES TO BE SET ASIDE FOR MAINTENANCE OF THE LAW LIBRARY.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

#### SECTION 1.

Section 2 of Washoe County Ordinance No. 1 is hereby amended to read as follows:

### SECTION 2. Law Library Fund: Fees set aside.

On the commencement in, or removal to, the District Court of Washoe County of any civil action, proceeding or appeal, on filing the first papers therein, the clerk of the court shall set aside from the costs received the sum of \$15 in each case for a fund which shall be and is hereby designated as the "Law Library Fund" to be expended in the establishment and maintenance of a law library in the county seat of the county, which law library shall be governed and controlled as provided for in the act of the Legislature of the State of Nevada.

#### SECTION 2.

Section 4 of Washoe County Ordinance No. 1 is hereby repealed.
