

GAMING LICENSING BOARD ORDINANCE NO. 527

AN ORDINANCE AMENDING "AN ORDINANCE REGULATING GAMING, REQUIR-ING LICENSING OF GAMING ESTABLISHMENTS IN THE UNINCORPORATED AREA OF WASHOE COUNTY; PROVIDING PENALTIES FOR VIOLATION OF THE PROVISIONS OF THIS ORDINANCE; AND OTHER MATTERS PROPERLY RELATING THERETO" BY MAKING A TECHNICAL CORRECTION TO SECTION 8 OF THAT ORDINANCE.

THE GAMING LICENSING BOARD OF THE COUNTY OF WASHOE, STATE OF NEVADA, DO ORDAIN:

SECTION 1. Section 8 of Gaming Licensing Board Ordinance No. 1 is hereby amended to read as follows:

SECTION 8. Special County License Fees

In addition to the general county licensing fees as provided in NRS 463.390, the license fees contained in Washoe County Ordinance No. 306, Section 27(A) shall also be assessed.
