SUMMARY: Amends Washoe County Code by increasing room tax to conform to state law.

BILL NO. 746

ORDINANCE NO. 573

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY INCREASING THE ROOM TAX TO CONFORM TO STATE LAW AND SETTING FORTH REQUIREMENTS FOR THE DISTRIBUTION AND USE OF THE ROOM TAX.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 25.151 of the Washoe County Code is hereby amended to read as follows:

25.151 Imposition and rate of tax.

1. There is hereby fixed and imposed a license tax for revenue on every licensee operating a rental business within the county and located and situated outside of the corporate limits of incorporated cities and towns of the county, in addition to license taxes heretofore fixed and imposed and now existing, in the amount of 6 percent of the amount of gross income derived from room rentals received by each licensee from the renting of rooms within the corporate limits of the county and outside the corporate limits of incorporated cities and towns of the county.

2. There is hereby fixed and imposed an additional license tax in the amount of 1 percent of the gross income from room rentals subject to the tax levied pursuant to subsection 1. The additional tax shall be collected, disbursed and used in compliance with Senate Bill No. 170 of the Sixty-second session of the Nevada Legislature.


