ORDINANCE NO. 580

AN ORDINANCE INITIATING PROCEEDINGS FOR THE ORGANIZATION OF THE LAWTON VERDI GENERAL IMPROVEMENT DISTRICT PROPOSED FOR FURNISHING WATER, SEWERAGE AND STORM DRAINAGE FACILITIES; PROVIDING FOR WRITTEN NOTICE OF HEARING AND HEARING ON THE CREATION OF THE DISTRICT.

WHEREAS, the County of Washoe, in the State of Nevada, is a County incorporated and operating under the laws of the State of Nevada; and

WHEREAS, the Board of County Commissioners of the County (herein designated as the "Board") is authorized and empowered under NRS 318.050 and NRS 318.055, in addition to the powers elsewhere conferred upon the Board, to initiate proceedings for the organization of a water, sewerage and storm drainage district.

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE COUNTY OF WASHOE, IN THE STATE OF NEVADA, DO ORDAIN:

### SECTION 1.

Proceedings are hereby initiated for the formation of a water, sewerage and storm drainage district pursuant to Chapter 318, Title 25 of the Nevada Revised Statutes.

#### SECTION 2.

The name of the proposed district will be the Lawton Verdi General Improvement District (hereinafter designated as the "District").

### SECTION 3.

The basic powers of the District shall be:

- (a) Furnishing water facilities, as provided in NRS 318.144.
- (b) Furnishing sewerage facilities, as provided in NRS 318.140.
- (c) Furnishing storm drainage facilities, as provided in NRS 318.135.

#### SECTION 4.

The general description of the boundaries of the District are the coterminous exterior boundaries of the composite and consolidated area consisting of the several parcels of land described in the exhibit entitled Exhibit "A" hereto attached and by reference made a part hereof, comprising the area commonly known as the Belli Ranch Subdivision.

# SECTION 5.

The lands within the District are within seven miles from the boundaries of the City of Reno, an incorporated city of the State of Nevada. Accordingly, all members of the Board have unanimously agreed to the initiating of proceedings for the organization of the District within the lands, the boundaries of which contravene the seven-mile limitation described in the statute, as permitted by NRS 318.055.

# SECTION 6.

The ordinance creating the Lawton Verdi General Improvement District will be based upon the finding of the Board of County Commissioners:

- (a) That the public convenience and necessity require the creation of such District;
- (b) That the creation of such District is economically sound and feasible:
- (c) That the service plan for the District conforms to subsection 1 of NRS 308.030; and
- That the service plan for the District does not contravene any of the criteria enumerated in subsection I of NRS 308.060.

SECTION 7. October 25, 1983 October 25, 1983 , at the hour of 9:55 o'clock a.m., in the Chambers of the Board, 1205 Mill Street, Reno, Nevada, is hereby fixed as the time and place when and where the Board will have a hearing on the creation of the District, after which the Board will make its findings whether or not the ordinance creating said District is required by necessity and public convenience and whether or not the creation of the District is economically sound and feasible. All interested persons may be heard at the hearing.

### SECTION 8.

The County Clerk shall mail written notice to all property owners within the District of the intention of the Board to establish the District. The notice shall set forth the name, statement of purposes, general description and time and place of hearing.

## SECTION 9.

This ordinance shall be in full force and effect from and after its passage, approval and publication as prescribed by NRS 244.100.
