

COUNTY LICENSING BOARD ORD. NO. 587

AN ORDINANCE AMENDING GAMING LICENSING BOARD ORDINANCE NO. 1 CLARIFYING THE PROVISIONS FOR SANCTIONS AGAINST LICENSEES WHO ALLOW EMPLOYEES TO WORK WHO HAVE NOT SECURED REQUIRED WORK PERMITS.

THE COUNTY LICENSE BOARD OF THE COUNTY OF WASHOE, STATE OF NEVADA, DOES HEREBY ORDAIN:

SECTION 1. Gaming License Board Ordinance No. 1, which is incorporated in the Washoe County Code as Sections 30.335 to 30.430, is hereby amended by adding thereto a new section 12.5, which shall be printed as section 30.418 in the Washoe County Code.

30.418 Employment of unauthorized personnel prohibited:

1. It is unlawful for any licensee to employ or allow to be employed any gaming employee, as defined in section 30.440, who does not hold a current valid work permit as required by sections 30.435 to 30.510.

2. In addition to criminal sanctions, a violation of this section is grounds for revocation or suspension of a

gaming license.

3. In any proceeding to revoke or suspend a gaming license on the basis of an alleged violation of this section, a defense of good faith belief by a licensee shall not be accepted or considered if the licensee refuses to testify under oath in any related civil or criminal proceeding that the employee produced a facially valid work permit and that the licensee had a bona fide belief that the permit was valid.
