

SUMMARY: Amends the Washoe County Code to create a Board of Massage Examiners.

BILL NO. 762

ORDINANCE NO. 590

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE TO CREATE A BOARD OF MASSAGE EXAMINERS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1.</u> Chapter 25 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

25.XXX Board of massage examiners: Creation; composition. There is hereby created a board of massage examiners to be composed of five members who shall be residents of the county. The board shall consist of the district attorney or his designee; the sheriff or his designee; and three persons to be appointed by the licensing board of Washoe County. One of these appointees shall be a licensed masseur and the other two shall be licensed members of the medical community, either a physician, nurse, chiropractor or physical therapist.
