

ORDINANCE NO. <u>599</u>

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY ADDING A SECTION PROVIDING FOR CRIMINAL PENALTIES FOR VIOLATION OF ORDINANCES ADOPTED BY LICENSING BOARDS.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 30 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

30.XXX <u>Licensing board ordinances: Penalty for violation.</u> Any person committing an act which is declared unlawful by any regulation or ordinance adopted by the liquor licensing board of the County of Washoe or the gaming licensing board of the County of Washoe or any other board which has the power to adopt regulations or ordinances is guilty of a misdemeanor and shall be punished as provided in section 125.050 of this code.
