ORDINANCE NO. 609

AN ORDINANCE AMENDING CHAPTER 110 OF THE WASHOE COUNTY CODE BY ADDING THERETO PROVISIONS CREATING THE DEPARTMENT OF COMPREHENSIVE PLANNING.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 110 of the Washoe County Code is hereby amended by adding thereto the provisions set forth as sections 2 through 6, inclusive, of this ordinance.

SECTION 2.

Department of comprehensive planning: 110.0200 Creation.

There is hereby created the Washoe County department

of comprehensive planning.

The department shall be responsible for the development and administration of comprehensive planning programs for the county in accordance with relevant local, state and federal ordinances, laws and regulations, as well as such other functions as may be assigned by the board of county commissioners.

SECTION 3.

110.0201 Director of department of comprehensive planning: Position created; appointments; term; staff.

1. The position of director of the department of comprehensive planning is hereby created. The director shall be appointed by the county manager and shall serve at the pleasure of the county manager.

The director shall appoint, pursuant to any applicable provisions of law regulating county personnel, such technical, clerical and operating staff as the execution of the duties of the director and operation of the department may require.

SECTION 4.

110.0202 Director of department of comprehensive planning: Powers and duties. As the executive head of the department, the director shall direct and supervise all administrative, technical and operational activities of the department. In addition to such activities as may be required in the daily administration of the department, the board of county commissioners may make additional assignments as deemed necessary.

SECTION 5.

110.0203 Compensation of director, employees of depart-

ment of comprehensive planning; payment of salaries.

1. Except as provided in subsection 2, the salaries and other fringe benefits of the director and employees of the department of comprehensive planning shall be established in accordance with the provisions of the Merit Personnel Ordinance or any other applicable laws regulating the

employment of county personnel.
2. The salary for the position of director shall be

established by the board of county commissioners.

SECTION 6.

110.0204 Divisions of department of comprehensive planning. The department shall consist of such divisions, created upon the recommendation of the director of the department of comprehensive planning, as are deemed necessary to the efficient performance of the duties of the department.
