BILL NO. 842

ORDINANCE NO. 668

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY PROHIBITING CERTAIN PHYSICAL CONTACT DURING THE PERFORMANCE OF A MASSAGE AND MAKING SUCH PROSCRIBED CONTACT A CRIMINAL OFFENSE AND A GROUND FOR REVOCATION OF A PERMIT OR LICENSE.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 25 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

25.244 Unlawful touching: Crime, grounds for revocation of license or permit.

- 1. It is unlawful for a masseur or massage technician or employee of a massage business to intentionally massage or touch or fondle the genital or anal area of any patron or the breasts of a female patron.
- 2. The license or permit of any person who violates the provisions of this section may be revoked on the basis of such violation.
- 3. The license of a holder of a massage business license whose employees violate the provisions of this section may be revoked on the basis of the violation by the employee.
- 4. Any person violating the provisions of subsection 1 of this section shall, in addition to revocation of his license or permit, be guilty of a misdemeanor.
