ORDINANCE NO. <u>688</u>

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY REVISING THE METHOD OF ESTABLISHING POLICIES FOR THE PUBLIC USE OF COUNTY BUILDINGS AND FACILITIES.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 80.450 of the Washoe County Code is hereby amended to read as follows:

80.450 Building use: Policy; compliance by county departments.

1. Except as provided in section 80.460, all departments of the county shall comply with the building use policy adopted by the board of county commissioners.

- 2. The board of county commissioners shall, by formal resolution, adopt a facility use policy statement containing the details and the conditions of use of county facilities. The board may, by formal resolution, amend that statement.
- 3. The facility use policy statement must be kept on file with the county manager and the general services department and must be made available for inspection during regular business hours.
- SECTION 2. Section 80.460 of the Washoe County Code is hereby amended to read as follows:

80.460 Exemptions from policy: Libraries; others.

- 1. All county library facilities are exempt from the building use policy statement enacted pursuant to section 80.450 if the board of trustees of the library has adopted rules governing the use of those facilities.
- 2. County buildings or other facilities having revenuegenerating policies may be exempted from specific provisions of the policy statement upon appeal to the board of county commissioners and a showing of good cause.

<u>SECTION 3.</u> Sections 80.470, 80.480, 80.490, 80.500, 80.510, 80.520, 80.530 and 80.540 of the Washoe County Code are hereby repealed.

<u>SECTION 4.</u> Sections 80.550, 80.560, 80.570, 80.580 and 80.590 of the Washoe County Code are hereby renumbered and shall be designated as 80.470, 80.480, 80.490, 80.500 and 80.510 respectively.

SECTION 5. Section 4 of this ordinance becomes effective one minute after Section 3 of this ordinance becomes effective.
