SUMMARY: Amends the Washoe County Code provisions relating to massage licenses by changing number and selection of board members, modifying the testing requirements, eliminating sunset clause, and other matters relating thereto.

ORDINANCE NO. 692

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE PROVISIONS RELATING TO MASSAGE LICENSES BY CHANGING NUMBER AND SELECTION OF BOARD MEMBERS, MODIFYING THE TESTING REQUIREMENTS, ELIMINATING SUNSET CLAUSE, AND OTHER MATTERS RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 25.238 of the Washoe County Code is hereby amended to read as follows:

25.238 Board of massage examiners; creation; composition; replacement; meetings; examinations; recommendations.

- 1. There is hereby created the board of massage examiners to be composed of five regular members and two alternate members who shall be residents of the county. The board shall consist of the district attorney or his designee; the sheriff or his designee; and three persons to be appointed by the licensing board of Washoe County. At least one of these appointees shall be a licensed masseur, and at least one shall be a licensed member of the medical community, either a physician, nurse, chiropractor or physical therapist. The term shall be for two years.
- 2. Upon recommendation by the sheriff or his designee supported by evidence that a board member has not faithfully performed his duties or that a majority of the board has requested the removal of any board member, the county licensing board may require such member to be removed and replaced with another qualified person.
- 3. The board shall meet on the first Monday of each month unless there are no applications pending.
- 4. The board shall conduct an examination of all applicants for a masseur's permit, which examination shall consist of an oral examination, a written test and a practical examination. The oral and written examination shall test the applicant's knowledge of anatomy, kinesiology and physiology and of state, city, and county laws (including health and any other law, rule or regulation the board may determine applicable to the

practice of massage) and relevant inquiry into the background and qualifications of the applicants. The practical examination shall consist of the actual performing of massage services upon the technician member of the board or upon such person as he shall designate. An applicant who fails to pass the examination will be allowed to take the examination again, but no more than three attempts will be allowed.

5. The board shall grade and assess the examination and make its recommendation to the sheriff.

SECTION 2. Section 25.240 of the Washoe County Code is hereby amended to read as follows:

25.240 Renewal.

- 1. Unless otherwise specified, a license or permit shall be valid for 1 year after the first day of the month in which it was issued. Application for renewal of an existing license or permit may be made no more than 45 days nor less than 15 days prior to the expiration of the existing license or permit. The application shall contain the same information and shall be subject to the same requirements and be processed in the same manner as an original application.
- 2. Upon receipt of an application for a renewal of a license or permit the sheriff shall conduct such investigation as he deems necessary in light of any new information or changed circumstances and shall inform the board of massage examiners of the application. The board may waive the examination or any part thereof if it does not appear that there has been any significant changes in the applicant's status since the issuance of the last license, provided that all masseurs shall be required to take a written test at least every three years and, if the board deems it necessary, to also take the oral examination.

SECTION 3. Section 25.243 of the Washoe County Code is hereby amended to read as follows:

25.243 Fees.

- 1. The fee for a message business license shall be as set forth in section 20.025 of this code.
 - 2. The fee for a masseur's permit shall be \$29.
- 3. The fee for a temporary massage technician's permit shall be \$29, which will be applied against any fees required for a subsequent application for a masseur's permit.
- 4. The investigation fee for an application for any license or permit shall be \$100, except that if an applicant has not continuously resided in the State of Nevada during the 6 months previous to the date of

application the fee shall be \$200.

- 5. The fee for the testing and hearing before the board of massage examiners will be \$15.
- 6. The fee for an identification card shall be the same as for a standard work card.
- 7. An applicant who has been investigated within the last 12 months will not be required to pay an additional investigation fee upon a subsequent application for the same or similar license or permit.
- 8. The sheriff may waive the investigation fee for an applicant for renewal of an existing valid license where it does not appear that there has been any significant change in the applicant's status since the last issuance of the license and there have been no complaints against the applicant which warrant investigation.
- 9. Members of the board of massage examiners will be exempted from the fee requirements.

SECTION 4. Section 25.249 of the Washoe County Code is hereby amended to read as follows:

25.249 License or permit transfers.

- 1. A license or permit is not transferable, severable or divisible, and the privilege conferred by a license or permit is conferred only upon the licensee or permittee named therein.
- 2. A massage business license may be transferred to a different location provided that there will be no change in ownership of the business and there has been compliance with the requirements of sections 25.237(2) and 25.239(2)(b).
- 3. Any such proposed transfer shall first be submitted to the sheriff and such other departments as he may designate. No action will be required to be taken on such application until the applicant has paid the appropriate fee required by each department.

SECTION 5. Section 25.259 of the Washoe County Code is hereby amended to read as follows:

25.259 Exemptions.

- 1. The licensing or permit requirements of sections 25.227 to 25.261 do not apply to:
- (a) Any licensed health and care facility as defined in NRS 449.007; or
- (b) Any licensed provider of health care as defined in NRS 629.031 where the performing of massages is an adjunct of providing health care; or
- (c) Any person providing services under the direction and supervision of such licensed provider in conjunction with the providing of services by an exempted facility; or
 - (d) Barbers or cosmetologists holding a valid state

license or certificate while lawfully carrying out their particular business or profession at the location of their county business license.

SECTION 6. Section 25.2611 of the Washoe County Code is hereby repealed.
