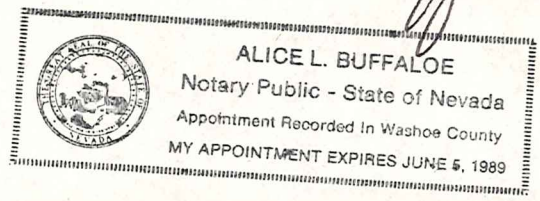

SUMMARY: Amends Washoe County Code by changing method of calculating longevity pay for justices of the peace.

BILL NO. 877

ORDINANCE NO. 702

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY REVISING PROVISIONS SETTING FORTH THE METHOD OF CALCULATING PAYMENT FOR LONGEVITY FOR JUSTICES OF THE PEACE.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 5 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

5.146 Career incentive plan for justices of the peace.

1. A justice of the peace who has served in his office for more than 4 years is entitled to an additional salary of 1 percent of his base salary for each full calendar year he has served in his office. The additional salary provided in this section must not exceed 20 percent of the base salary of the justice of the peace.

2. Payment for longevity under the provisions of this section must be computed on the basis of full calendar years of service and only at the beginning of a term.

SECTION 2. The leadline of section 5.145 of the Washoe County Code is hereby amended to read as follows:

5.145 Career incentive plan for employees; inapplicability to certain elected county officials and certain employees.

SECTION 3. This ordinance becomes effective on January 1, 1987.




