ORDINANCE NO. 727

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY IMPOSING AN ADDITIONAL FILING FEE TO BE PAID BY THE DEFENDANT IN ACTIONS FOR DIVORCE, ANNULMENT OR SEPARATE MAINTENANCE.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 20 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

20.700 Imposition of additional filing fee in actions for divorce, annulment or separate maintenance; collection.

- Pursuant to NRS 19.033, there is hereby imposed an additional filing fee of \$5 to be paid in each action for divorce, annulment or separate maintenance filed in the Second Judicial District Court of the State of Nevada, in and for the County of Washoe.
- The fee imposed pursuant to subsection 1 must be paid by the defendant upon the filing of the first paper in such an action by the defendant. The payment of the fee is a condition precedent to the filing of the first paper by the defendant.
- On or before the 5th day of each month, the county clerk shall account for and pay to the county treasurer all fees collected during the preceding month pursuant to this section.
