AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY ADDING PROVISIONS WHICH WERE UNINTENTIONALLY OMITTED DURING CODIFICATION; MAKING MINOR TECHNICAL CHANGES:

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1.</u> Chapter 5 of the Washoe County Code is hereby amended by adding thereto a new section which shall read as follows:

5.334 <u>Full-time service required.</u> Each employee shall, during his hours of duty as an employee and subject to such other laws, rules or regulations as pertain thereto, devote his full-time attention and efforts to county employment.

Note: This section was formerly \$160 of Ord. No. 213, but was omitted during the 1982 codification.

- SECTION 2. The Washoe County Code is hereby amended by making the following corrections to the source notes of the following sections:
 - 1. The source note of section 5.337 is amended to read: "§158, Ord. No. 213; A Ord. No. 492."
 - 2. The source note of section 5.339 is amended to read: "§159, Ord. No. 213; A Ord. No. 492."

Note: Technical corrections.

SECTION 3. Section 15.450 of the Washoe County Code is hereby repealed.

Note: This section repeals obsolete County Code provisions pertaining to application to the board for grants to provide aid for victims of domestic violence. Applications are now made to the mental health and mental retardation division of the state department of human resources, which also awards the grant money. See NRS 217.440(1).
