ORDINANCE NO. 758

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY CREATING A FUND IN THE COUNTY TREASURY DESIGNATED AS THE FUND FOR FOREN-SIC SERVICES TO BE USED FOR THE DEPOSIT OF FORENSIC ANALYSIS FEES COLLECTED BY THE DISTRICT, MUNICIPAL AND JUSTICES' COURTS FROM DEFENDANTS ACCUSED OF VIOLATING NEVADA'S CONTROLLED SUBSTANCE LAWS AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Chapter 15 of the Washoe County Code is hereby amended by adding thereto a new section which shall be numbered 15.085 and which shall read as follows:

15.085 Forensic services fund. The forensic services fund is created pursuant to subsection 5 of NRS 453.575 as a separate account in the county general fund. The fund exists for the receipt and disbursement of all revenues received pursuant to that NRS section from the municipal, justices' and district courts.
