SUMMARY: Amends Washoe County Code by revising county gaming license fees.

BILL NO. 943

ORDINANCE NO. 768

AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY REVISING COUNTY GAMING LICENSE FEES TO CONFORM TO THE NEVADA REVISED STATUTES.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. Section 30.390 of the Washoe County Code is hereby amended to read as follows.

30.390 License fees. Pursuant to NRS 463.390, there is hereby imposed a quarterly license fee for the operation of a business wherein games, tables, machines or devices are operated. The amount of that fee shall be determined on the basis of the number and types of games, tables, machines or devices contained on the premises.

1. The fee shall be the cumulative total of the calculations based on the following formula:

(a) \$25.00 for each card game, including but not limited to, stud and draw poker, bridge, whist, solo and panguini for money.

(b) \$10.00 for each slot machine unit whether operated solely by a single handle or in combination with another unit with the same handle.

(c) \$50.00 for each game or device other than those described in paragraphs (a) and (b).

2. The fee will be due and payable quarterly in advance on January 1, April 1, July 1, and October 1 and will not be refundable after the license is issued.




